ARTICLES OF INCORPORATION

OF

KLAHANIE ASSOCIATION

I, the undersigned person of the age of eighteen (18) years or more, hereby adopt in duplicate the following Articles of Incorporation, for the purpose of forming a corporation under the Washington Nonprofit Corporation Act, Chapter 24.03 of the Revised Code of Washington.

ARTICLE I. NAME AND DURATION

The name of this corporation shall be Klahanie Association, and its existence shall be perpetual.

ARTICLE II. PURPOSES AND POWERS

The purpose for which the corporation is organized is to provide for the recreation, health, safety and welfare of the Klahanie community and its residents located on the East Sammamish Plateau in King County, Washington, and to engage in all such activities as are incidental or conducive to the attainment of the objectives of the corporation and all activities which are permitted to be done by a nonprofit corporation under any laws that may now or hereafter be applicable or available to this corporation. The powers of

this corporation shall be subject to and shall be exercised in accordance with the provisions of the Declaration and Covenants, Conditions, Restrictions, and Easements for Klahanie: A Master-Planned Community, filed with the Department of Records and Elections of King County, Washington, under Recording No. 8502060789, as it may from time to time be amended, hereinafter referred to as the "Declaration."

ARTICLE III. REGULATION OF INTERNAL AFFAIRS

Provisions for the regulation of the internal affairs of the corporation shall be set forth in By-Laws, and in the Declaration.

ARTICLE IV. DISTRIBUTION OF ASSETS ON DISSOLUTION OR FINAL LIQUIDATION

Upon dissolution or final liquidation of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute any remaining assets of the corporation, to the extent permitted under any applicable law, to such organization or organizations as may be selected by the Board of Directors. Any such assets not so distributed

shall be disposed of as determined by the Board of Directors in accordance with any applicable laws.

ARTICLE V. MEMBERS

The corporation shall have one class of members, which shall consist of the owners of lots and living units in the Klahanie community, as provided for in the Declaration.

ARTICLE VI. INITIAL DIRECTORS

The initial directors of this corporation shall be three (3) in number, and their names and addresses are as follows:
